

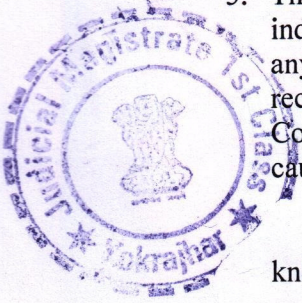




3. That the name of the Trustee / Member as mentioned in the above column are not related to each other by blood.


